READ INSTRUCTIONS CAREFULLY BEFORE PLACING STICKER ON INSIDE OF FRONT WINDSHIELD WITHIN 6 INCHES OF THE SAFETY INSPECTION STICKER.

1. Remove the expired windshield sticker from the inside front windshield. Clean the area with soap and water to remove any remaining residue.
(NOTE: A household glass cleaner may be necessary to remove the residue. Use caution to ensure that cleaner does not damage the vehicle inspection sticker.)
2. Make sure the area is clean and dry.
3. Peel the strip of protective covering from the face of the sticker until approximately 1/2 inch of the sticker is exposed.
4. Place the sticker on the inside of the front windshield within six inches of the safety inspection sticker.
5. Peel off the remaining protective covering and press the sticker firmly to the windshield.
